Event Objectives

The *Intensive Intervention Institute* aims to build knowledge and capacity of state and local leaders and teacher preparation faculty to support implementation of intensive intervention for students with severe and persistent learning and/or social, emotional, or behavioral needs using data-based individualization (DBI).

During the event, participants will:

- Learn about the DBI process
- Discuss DBI research and implementation lessons with NCII staff, advisors, and national experts.
- Access role-specific (LEA, SEA, teacher preparation faculty) professional learning and action planning opportunities.
- Network with colleagues interested in supporting intensive intervention implementation.
- Access freely available resources and tools to support intensive intervention implementation.

Strand Session Options

Participants will choose to join one of three strand sessions based on their role.

- ***Local Education Agency (LEA)/District Strand:*** Attendees of the LEA strand will learn about supporting DBI implementation in their district. They will network with others in similar roles and develop or revise an implementation plan to support their schools.
- ***State Education Agency (SEA) Strand:*** Attendees of the SEA strand will learn about scaling up and sustaining DBI implementation from the state perspective. They will network with others state staff and develop or revise an implementation plan to support schools and districts in their state.
- ***Teacher Preparation Faculty Strand:*** Attendees of the faculty strand will learn strategies for embedding intensive intervention content and resources into coursework and field experiences for preservice and inservice teachers. Faculty will review and revise at least one course syllabus to reflect intensive intervention course content.
